2. The camp may deny employment to any person who answers "yes" to questions 1-6. If hired and the employer later discovers circumstances that would indicate a "Yes" answer to any of the above questions, employment or volunteer service may be terminated immediately.
3. The information provided on this form is subject to verification, which may include a criminal history check and request from any Central Registry of child abusers.
4. The camp may terminate employment or volunteer service of any person if that person is found, regardless of when discovered, to:
 - a. have a history of complaints of abuse of a minor, and/or,
 - b. have resigned, been terminated, or been asked to resign from a position whether paid or unpaid, due to complaint(s) of sexual abuse of a minor, and/or,
 - c. have falsified or omitted information in this disclosure statement
5. This disclosure statement must be updated yearly and immediate notification provided to the camp if any information provided changes
6. CPS and CJIS background checks are legally required for my employment/volunteer service at Camp Mardela for the following roles:
 - a. ALL paid staff
 - b. Volunteers who are:
 - i. staying overnight on camp property, and/or
 - ii. working for more than 12 hours during any 1 camp program and/or
 - iii. required to be in camper's private space (cabins, bath houses, medical facilities), and/or
 - iv. required to be alone with campers
7. The staff/volunteer will be asked to cover the initial costs of these checks and will be reimbursed by Camp Mardela upon receiving a receipt of completion of services. If the staff/volunteer does not wish to be reimbursed, a receipt must be sent and a charitable contribution letter will be given for the amount of the background check fees.
8. Failure to complete these required background checks will bar any staff or volunteer from access to campers in the capacities listed above.
